Privacy Policy

This Privacy Policy ("Policy") applies to www.nescornholelounge.com, and NES Cornhole Lounge ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.nescornholelounge.com. The Company's website is a sports and event venue site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:
